Official Rules and Regulations (the "Contest Rules")

NO PURCHASE REQUIRED TO ENTER OR WIN

THE CONTEST PERIOD

The Contest entry period commences at 11:00 AM Eastern Time ("ET") on September 20, 2026 and concludes at 3:00 PM ET on November 8, 2026, subject to subsection 5.5 of the Contest Rules (the "Contest Period").

1. ELIGIBILITY

The Contest is open to residents of Canada, who are eighteen (18) years of age or older. Royal Irish Tours, Shine Travel (collectively, the "Contest Sponsors"), The Wedding Ring Inc. ("Administrator"), their affiliates, as defined in the Canada Business Corporations Act (the "Affiliates") and respective employees, directors, officers, agents, successors, assignees, advertising and promotional agencies, involved or not in the Contest, as well as family and household members of any of the foregoing are not eligible to enter the Contest or win a Prize. For the purpose of these Contest Rules, "family" means spouses, children, parents, grandparents, siblings (including step relatives) and their respective spouses, and/or persons with whom they are domiciled. Participant must meet the eligibility requirements as outlined in the Contest Rules throughout the entire Contest Period.

2. SPONSOR

Entry: To enter to win, the Contestant must attend a Wedding Ring Expo and sign in at the registration desk. Contestants may pre-register to attend the expo or register at the door. Contestants may enter to win once per expo.

For the purpose of the Contest Rules, "Contestant" means each Contest participant that meets the criteria mentioned above. The prize is not transferable and cannot be redeemed for cash or substituted for any other items by the winners. The winners cannot assign or transfer a prize. Royal Irish Tours and Shine Travel reserve the right to substitute a comparable prize of like or greater value, for any prize, for any reason.

The decisions of the Sponsor with respect to all aspects of this Contest are final and binding on all entrants without right of appeal.
- The Sponsor reserves the right to cancel, suspend, withdraw or amend this Contest in any way, without prior notice or obligation, in the event of an error, technical problem, computer virus, bugs, tampering, unauthorized intervention, fraud, technical failure or any other cause beyond the reasonable control of the Sponsor that interferes with the proper conduct of this Contest as contemplated by these Contest Rules. Any attempt to deliberately undermine the legitimate operation of this Contest is a violation of criminal and civil laws and should such an attempt be made, the Sponsor reserves the right to seek remedies and damages to the fullest extent permitted by law, including criminal prosecution.
